Connecting Foster Carers – SA Inc (CFC-SA) has been advocating strongly for the inclusion of carers' rights to challenge decisions that affect them and the children in their care within the child protection legislation. CFC-SA is thrilled to note that its advocacy efforts have been heard and this inclusion has been made in the draft Bill despite this recommendation being omitted by the Nyland Report. Under the proposal, the South Australian Civil and Administrative Tribunal (SACAT) will have the power to make binding decisions and carers will be able to appeal decisions of SACAT to the Supreme Court.

Other big wins for carers within the draft Bill include:

- ✓ easier access to Other Person Guardianship (OPG)
- ✓ entitlement to access information about a child upon placement
- √ involvement in court processes
- √ additional resources allocated towards foster and kinship care

CFC-SA is in the process of reviewing the draft Bill and preparing a response. It is likely CFC-SA will seek further changes allowing the Youth Court to join carers as parties to proceedings – to ensure this right is absolute and not discretionary.

... 3,321 children were in out of home care as at 31/10/2016

... 1,288 children were living with foster care families

... 1,473 children were living with kinship care families

... Foster and kinship carer families are providing homes for 83% of children in out of home care

General Meeting, with special guest speaker Cathy Taylor

CFC-SA hosted a General Meeting on 6 December 2016 and invited members to come along and hear from the new Chief Executive of the Department for Child Protection, Cathy Taylor. Cathy acknowledged the "hearts and homes" that foster and kinship families provide and assured the audience she views carers as "a critical part of the care team".

Cathy spoke of the great amount of work ahead across many elements of the system, and acknowledged **the priority for** <u>all</u> **is for the children and young people**.

Carers had the opportunity to ask a few questions, including:

- Timeliness around Department responses in actioning supports for children's needs and removing delays for day to day decisions; and
- What it means to transfer responsibility from the Minister to the Chief Executive

 and the impacts for carers.

Cathy reinforced the communication pathways for carers should begin at the local level and has welcomed further questions and examples of good practices from foster and kinship carers. Questions and examples may be emailed to support@cfc-sa.org.au to be passed on to Cathy.
