## CFC-SA’s response to the draft *Children and Young People (Safety) Bill 2016 (SA)*

CFC-SA has supported the introduction of new legislation and celebrates the inclusion and acknowledgement of Carers as an essential part of the child protection system.

The importance of new legislation cannot be understated – *getting it right from the outset* will see children and young people entering the care system have the best possible opportunities and see Carers enjoy legal protection, ensure greater stability and reduce the expense to the system through improved recruitment and retention and less reliance on residential care services.

CFC-SA has submitted further proposed changes to the “Bill” in efforts to address, protect and improve Carers’ rights, in particular:

- Carers to be heard absolute, subject to the best interests of the child or young person, and not discretionary;
- allow for urgent hearings at SACAT in relation to matters that arise from the new legislation; and
- ensure Carers are not at risk of being imprisoned for any term, or fined for any sum, beyond those imposed on the general public.
