**NEW INQUIRY: LOCAL ADOPTION
INVITATION TO MAKE A SUBMISSION**

The House of Representatives Standing Committee on Social Policy and Legal Affairs has commenced a new inquiry into a nationally consistent framework for local adoption in Australia, with a view to providing stability and permanency of care for children in out-of-home care, with local adoption as a viable option.

In 2015-16 over 46,000 children were in out of home care. During the same period 278 local adoptions were finalised. Guided by the principle of what is in the best interests of the child, the Committee is keen to understand whether there are unnecessary barriers to local adoption in Australia and, if so, the reasons for these barriers.

Once a document is received, the Committee decides whether to accept the document as a submission and publish it on its website. Please note that making a submission constitutes giving evidence and attracts parliamentary privilege. Once you have provided a submission to the Committee you cannot withdraw it or alter it without the Committee's permission. Please note that your document should not be disclosed to any other person until its publication has been authorised by the Committee.

While the Committee generally prefers that submissions be made public, you may request that part or all of your submission be kept confidential. Any request for confidentiality

should include reasons for the request, and be provided in writing for the Committee to consider.

TERMS OF REFERENCE

The House of Representatives Standing Committee on Social Policy and Legal Affairs will inquire into and report on approaches to a nationally consistent framework for local adoption in Australia, with specific reference to:

1. stability and permanency for children in out-of-home care with local adoption as a viable option; and
2. appropriate guiding principles for a national framework or code for local adoptions within Australia.

In undertaking its inquiry, the Committee will have regard to relevant legislative frameworks within Australia.
