I have had the honor of chairing Connecting Foster Carers – SA Inc (CFC-SA) since April 2017. It's been a steep learning curve for me, made much easier by the incredible work and support of our CEO, our hard-working volunteer board, and particularly our passionate and wise outgoing chair Jo Jarvis. (Jo is providing her own report on the year as she has seen it.) I'm grateful to them all – for welcoming me so warmly and helping me settle in. My first few months have been heady. My arrival coincided with a critical piece of legislation being before Parliament – the Children and Young Persons (Safety) Bill 2017 (SA). CFC-SA set about some intense lobbying, with great results. The government, at our urging, amended its own legislation to include new rights for Carers – including the right to have some decisions of the Department independently reviewed by the SA Civil and Administrative Tribunal (SACAT). That legislation has now passed, but has yet to come into effect. We will be keeping SA's foster and kinship carers (Carers) well and truly informed as to its progress. The changes bring our legislation into line with other states and have the potential to significantly improve the relationship between Carers and the Department for Child Protection (DCP) through improved accountability. Other highlights for me have been:

- chairing our open Board meeting in July, and meeting some of our Members
- meeting with relevant Ministers, and departmental and ministerial officials, to continue to press for progress on the Nyland Report recommendations (including better funding for carer advocacy and education services)
- learning about the challenges facing Carers and getting a deeper appreciation of the work CFC-SA does to support Carer families
- working with the board on its continued commitment to improve the governance of the organisation, bringing in new skills to meet identified needs

Thank you to all those who have served on the Board – past and present. We, your Board, are now starting work on a new Strategic Plan – to shape an organisation that can continue to predict and meet the needs of the SA foster and kinship carer community well into the future.

- a skill-based Board with key areas identified and filled, including legal, financial, system and individual advocacy, governance, and most recently public relations and media

My time as Chairperson of the CFC-SA Board has been an exciting time, which has involved a lot of hard work, tough conversations and new thinking. I believe the foundation that has been laid since CFC-SA was first incorporated in 1999 is providing a solid base to grow from. I wish to thank all those who have served on the Board of CFC-SA in the past. Your contribution has made a difference! I welcome those who are yet to come.

CEO'S REPORT

It has been my pleasure to serve as CFC-SA's first paid employee and Chief Executive Officer since August 2016. Joining CFC-SA upon the release of the Nyland Royal Commission has given me a solid understanding of the past, an insight into many of the challenges, but mostly an optimism for the future and a commitment towards ensuring improvements in foster and kinship care are a key part of child protection reform. During the 2016-17 financial year there has been a lot of progress across several aspects of the organisation including:

- membership, updating our Member records, providing opportunities for Members to attend special events at the Clipsal 500 and national Conference, and introducing special Member offers
- events, including hosting the annual Recharge event in 2016, two forums for Carers to meet with DCP Chief Executive, Cathy Taylor, DCP representatives sharing OPG information and data, and a family fun event at the Drive-in
- governance, with a new Constitution, completion of a 3-part Board governance training program and a resulting governance action plan to guide this important aspect of our work
- strategy, with a plan to provide direction and meet key areas of growth and advocacy
- operations, defining our services and supporting them with policies and procedures to ensure we meet legislative requirements
- child protection sector involvement, broadening our networks with key stakeholders and being a voice for Carers
- legislative change, ensuring foster and kinship carers have legal rights and those rights are protected
- media releases, including raising the issue of foster and kinship carers risking prison and substantial fines under the new Bill
- a new website, accessible on smart devices
- 2017 Foster and Kinship Carer survey (delivered during July 2017)
- growing our staff team, welcoming Natalie Baron (in December 2016) to manage our administrative needs and Jane Horton (in July 2017) to coordinate our volunteers and form the Peer Support Network

This work cannot occur without support of many. I would like to thank the community of foster and kinship carers across South Australia for their feedback and involvement in the sector. Thank you to all the CFC-SA Members who have signed up and encouraged us to continue to make a difference for Carer families. Thank you to the Board of CFC-SA who make decisions, provide invaluable insight and oversight and shape the future of CFC-SA. Thank you to the staff of CFC-SA who go above and beyond to deliver quality services.

OUR HISTORY

Connecting Foster Carers - SA Inc (CFC-SA) has been supporting South Australian foster and kinship carers (Carers) for over 20 years.

Evolving from a grassroots organisation, CFC-SA was incorporated in 1999 and continues to utilise **peer support** in the delivery of peak body services, strengthening individuals and families who provide family-based care for children and young people.

OUR MEMBERS

Members play an important part in shaping the future of CFC-SA and improving the system for Carer families.

The support of Members helps CFC-SA to speak up and be a voice for Carer families, advocate for improvements and deliver a better range of support services.

As of 30 June 2017, over 520 Member families were actively joining CFC-SA in this important work, 98 new members during 2016-17.

As a peak body, it is vitally important for CFC-SA to ensure that it understands the needs of its Members so that it may best represent their interests in CFC-SA's advocacy efforts and service development.

In July 2017, CFC-SA developed a draft Membership Strategy and sought the involvement of Members to shape our future work. A final draft was distributed in October 2017 for feedback, with the final document to be incorporated in the 2018 Strategic Plan.



OUR ACTIVITIES 2016-2017 ADVOCATE

Carers often face challenges and issues that impact their ability to provide care for vulnerable children and young people resulting in poorer life outcomes. Advocacy provides Carers with the opportunity to participate in decisions that impact the children and young people they care for, their lives and their families, and aims to ensure their rights as Carers are promoted and protected.

CFC-SA works to promote the voice of Carers, to have Carers' voices heard, and for Carers to be collectively recognised as an essential part of the child protection system.

This advocacy occurs at two levels: influencing positive changes to attitudes, policies, systems and laws through **systems advocacy**; and **individual advocacy**, helping Carers have an effective voice in matters that affect them and the children and young people in their care.

CFC-SA's **individual advocacy** was active during 2016-17 year, averaging one significant matter per week for Carers on a range of issues, including:

- care concerns
- carer investigations
- abrupt removals of children and young people from Carer families
- Other Person Guardianship (OPG)
- payments
- de-registration

The majority of communication on these issues occurred with DCP staff at local offices and we acknowledge all staff who took the time to review the individual circumstances for Carer families and work towards positive resolutions.

OUR ACTIVITIES 2016-2017 ADVOCATE

(... continued)

We thank the Carers who contacted our service and trusted us to help them have a voice and to share many of their learnings with the broader Carer community. While our **systems advocacy** was largely focused on legislative change and saw amendments passed in relation to the new Bill, it also involved areas of work across the sector including:

- an appointment to the Child Safety and Wellbeing Advisory Group
- as a member of the DCP Out-of-Home Care Steering Group
- involvement in Out-of-Home Care reform committee and providing feedback on the OOHC Program Charter and draft Engagement Plans
- seeking improvements to DCP processes, including responding to the 'Who can say OK?' revisions
- involvement in the Health and Social Consequences of Child Maltreatment Consumer Group with UNISA
- responding to the Recommendations from the Nyland Royal Commission Report
- response to the KPMG Foster & Kinship Care review and stakeholder interview
- response to the KPMG Carer Advocacy Services review and stakeholder interview
- seeking outcomes of KPMG reviews and providing feedback on the 'A Fresh Start' response to the Nyland recommendations
- joining the Home Stretch Campaign signing up to continue out-ofhome care support for young people to receive care to 21 years (and not end at age 18)

Many of these responses were submitted with feedback from Members included in our submissions. Thank you to all who lent their voices to our systems advocacy, including those who provided support online via the YourSAy website.

OUR ACTIVITIES 2016-2017 SUPPORT

CFC-SA offers support for Carers through the 1800 732 272, email and website enquiry lines, which aim to complement existing services or meet areas of support or need not currently available. CFC-SA focus is on collaboration and working in a coordinated manner that supports communication between Carers and other parties, while acting in the best interests of the child or young person.

Listening to Carers' experiences and acknowledging the importance of the caring role in each child and young person's life, CFC-SA supports the effective communication of Carers' needs and wants, and offers Carers additional benefits through access to **peer support** from experienced Carers.

During the year, CFC-SA:

- responded to 653 phone calls;
- replied to 71 email and website enquiries;
- attended 141 sector meetings; and
- engaged with a growing Facebook community 587 Likes and 572 Followers of our page as at 30 June 2017

We also took steps to improve our ability to provide support, for example:

- registered to make online CARL notifications
- CFC-SA has been approved by the Legal Practitioners Education and Admission Council (LPEAC) as an institution for the purposes of a Category D volunteer practising certificate. We intend to build this into our future advocacy service model, together with a broader range of volunteer support across other areas

OUR ACTIVITIES 2016-2017 CONNECT

CFC-SA's services are designed to work in partnership to promote the best interests of each child and young person and to protect and enhance the interests of all Carers in South Australia.

CFC-SA connects with the Carer community, Department for Child Protection, support agencies, kinship care teams and other key stakeholders to ensure effective consultation, coordination, communication and education on issues and activities which affect Carers.

CFC-SA offers opportunities for Carers to connect through events and activities, together with information about local support groups and other networks offering Carers' families a range of opportunities to share the achievements, joys, challenges and demands involved in parenting within the various contexts of the child protection system.

Opportunities to connect over the past year include the following events:

- Recharge 2016, held on 29/9/2016 with keynote speaker Fay Jackson, attended by 128 individuals, despite being held the day after the statewide blackout!
- Family Fun Event at the Drive-in (14 January 2017), attended by 70 car loads of Member families who came along to see the movie 'Sing!' and enjoyed the opportunity to socialise with other Carers and involve all the members of their family. Children and young people (and some adults) enjoyed the petting zoo and airbrush tattoos.
- 24/3/2017 Forum for Carers OPG Info session, sharing two Carer stories and DCP update from Robyn Skilbeck, and Q&A with Cathy Taylor
- Clipsal 500 tickets for 11 Members to attend the South Australia Suite at the invitation of Premier Weatherill and Minister Close

CFC-SA connects with other organisations within the child protection sector and is a member of the following organisations:

OUR ACTIVITIES 2016-2017 INFORM

CFC-SA aims to support Carers in identifying what is most important for them to know and what information will improve their parenting capacity and experience. Having access to the right information at the right time also lessens the amount of time Carers spend dealing with aspects of the child protection system and keeps the focus on their parenting role with children and young people.

CFC-SA also aims to inform potential Carers about the realities of foster and kinship care and offers the benefit of Carers' experiences to the broader sector on issues important to Carers and their families.

Many of the enquiries we receive seek general information about foster and kinship care, advice on children and young people's behaviour and placement support and advice regarding agencies and kinship care teams. To share information more widely we have taken the following measures:

- updated the CFC-SA website, continually update and add to our FAQ's from Carers and pass on information distributed by DCP
- utilised our Facebook page to sharing a range of posts relating to parenting, caring, children's behaviours, international practices, research, DCP updates and awareness weeks
- refreshed our Brochure to raise awareness about our range of services
- delivered a 2 page Newsletter each term, mailed out to all Carers in SA by DCP
- updated our email contact lists and included invitations to join CFC-SA as members in every communication
- developed a draft Carer Guide: The Role of a Support Person, intended for Carers when required to attend a meeting which examines matters relating to their foster or kinship caring responsibilities

OUR ACTIVITIES 2016-2017 INFORM

To help inform our learning and do more for foster and kinship carer families, we have:

- designed a 2017 Foster & Kinship Carer Survey (distributed during July 2017)
- provided feedback on resources for foster parents developed by Dr Sara McLean (we have met with Sara to help distribute these when available)
- met a request from DCP to provide feedback and distribute information to Carers on draft role descriptions for Carer Relationship Officer roles
- hosted Bryan Smith, CEO of Foster Care Queensland, in Adelaide to help inform our governance growth and service development



CHILD PROTECTION REFORM

On 6 July 2017 the *Children and Young People (Safety) Act 2017* (SA) ('Act') passed through the South Australian Parliament. Although the Act has not yet come into force it contains several sections that are in the interests of the rights and protection of South Australia's Carers, in particular the right to appeal against DCP decisions in the South Australian Civil and Administrative Appeals Tribunal ('SACAT'), an independent authority that has the <u>power to bind</u> the Department.

The decisions that are open to review by SACAT include, amongst other things, the:

- approval of Carers
- cancellation of approval of Carers
- delegation of power to approved Carers
- provision of information to approved Carers
- · inclusion of Carers in decision making
- referral of a child to long-term guardianship by the chief executive
- removal of a child from care

Previously Carers could seek review of decisions of the Ombudsman and/or the Health and Community Services Complaints Commissioner, neither of whom had the power to bind the Department.

CHILD PROTECTION REFORM (cont.)

CFC-SA wins in this area were hard fought. It is CFC-SA's understanding that CFC-SA was the only organisation that submitted to Commissioner Nyland that carers should have the right to appeal against decisions that affect them and the children in their care to SACAT; and despite Commissioner Nyland not supporting this submission and making recommendations contrary to it, CFC-SA was able to lobby for its inclusion in the Act.

CFC-SA would also like to report that it was able to have the initial proposed penalties for Carers dropped:

- for providing out of home care unless approved by law, from 2 years imprisonment to a \$10,000 fine; and
- for failing to comply with a condition of approval from 12 months imprisonment to a maximum \$10,000 fine

"Over the last few weeks, the government has met with stakeholders to further discuss measures in the bill, in particular Connecting Foster Carers-SA Inc. On behalf of the government, I wish to take this opportunity to acknowledge that group and thank them for their work on behalf of carers in this state. The government accepts that it is important to carers and important in terms of their retention and future recruitment that the bill provide an external review mechanism to allow decisions of the CE to either remove a child or change conditions as to their status as an approved carer. On this basis, the government urges members to support the amendment."

FINANCIAL REPORT

The Board of CFC-SA is pleased to present the Financial Report for 2016-17.

With an operating surplus of \$10,234, 2017 has been a good year for CFC-SA. The surplus in 2016 was \$4,134. Grant funding increased a hundred fold and was applied per funding agreements. The year also saw the strengthening of the Balance Sheet with increase in Cash Assets by 23.5%.

Our income was mainly derived from our contract with the Department for Child Protection, which has been extended into the current financial year, but which will *cease on 30 June 2018. In addition, DCP provided \$90,000 towards wages and CFC-SA introduced it's first employee in 2016.

[*CFC-SA will submit a tender application to deliver Carer Advocacy Services from 1 July 2018 and hopes to sign new contract arrangements with DCP.]

We were successful in a grant application to the Department for Communities and Social Inclusion, receiving \$11,229 to deliver the Peer Support Network Project. These funds will be expended in the current financial year.

CFC-SA has implemented stronger financial management processes, including:

- introducing MYOB accounting system for CFC-SA's finances
- registered CFC-SA for GST from 1 January 2017
- improving quality of Board reports
- submitting Australian Charities & Not for Profit Commission application for charitable status (approval pending)

We acknowledge the work of our Treasurers, Donna Scott and Marc Sodomka, and thank them for their time and management of CFC-SA's finances during the 2016-17 year and to our current interim Treasurer, Hastings Chikuse.

1. Basis of Accounting

This special purpose financial report has been prepared for distribution to the Board of Nanagement to fuffill the Board of Nanagement's financial accountability requirements under the Associations' Incorporation Act 1963 and CPC-SA's Constitution. The Board of Management has determined that the Association is not a reporting entity and, therefore, there is no requirement to apply Australian Accounting Standards and Urgent Issues Group Interpretations in the preparation of this report.

The accounting posicies used in the preparation of this report are described below and are, in the opinion of the Board of Management, appropriate to meet the needs of the Board of Management.

- (a) The financial statements have been propered on a cash basis of accounting including the historical cost convention and the going concern assumption. Adjustment has however been made so as to bring to account some employees' related and conference expenses incurred but not yet paid as at the reporting date, as set out in note # 2 below.
