### Shine a Light Conference Update

Highlights from our conference attendees were presented to guests at the recent CF&KC-SA AGM. Key messages included:

- The best predictor of future behaviour is past behaviour - don't be surprised when bad things happen; accept and be positive
  - All children need a story - they've lived their past and have survived it; they need to talk about it; be a safe and supportive space for these conversations
  - Poorer outcomes are experienced across the country for our Aboriginal children and young people - cultural care plans can be developed for Carer families (not just children); non-Aboriginal foster carers can begin the journey of cultural learning: just make a start!
  - Children and young people can recover from trauma and regain their potential; there should be no shame for Carers in seeking help or support

## International Foster Care Conference

### **2017 Malta**

CF&KC-SA Board member Donna Scott sits on the International Foster Care Organisation Board and holds the role of Vice Chairperson. Recently Donna attended the International Foster Care Conference in Malta and shared some of her highlights:

- The President of Malta was involved in the conference - she stayed, was committed to the children and young people and spent time with them talking about different problems.
- There were 3 groups of delegates, including children (ages 5-13) and youth (ages 14-28) with 30 young people from Malta who live in commercial care- type arrangements.
- A youth representative from Australia shared how lucky she felt to be growing up in foster care with her family.
- Foster care in India and Malta is not very good - they want to learn more, including a better understanding of their laws.
- IFCO Board executive appointments include four people with a care experience.

## SA EIRD Policy Brief

The South Australian Government's Early Intervention Research Directorate (EIRD) has released its first policy brief:

### **Identifying early intervention and prevention pathways for child protection concerns raised in pregnancy: Preliminary Findings from Child Protection Departmental Case File Reviews.**

The brief summarises the preliminary findings from a case file review study utilising a sample of Unborn Child Concerns in South Australia made in 2014. This is the first of a number of case file reviews being undertaken as part of

EIRD's work program by the Australian Centre for Child Protection. The study contributes to:


- Better understanding of concerns being raised to the Department for Child Protection about unborn children
- Examining patterns of risk factors, identifying subsequent child protection involvement for these children, and
- Recognising patterns in data to identify families who may benefit from early intervention and prevention efforts.

The three major findings of the report are:

- Early intervention and prevention potential is high
- Potential economic benefits of intervening in pregnancy with the identified target groups are also high
- A need for services to be designed for the target groups.

A case-file review to better understand the over-representation of Aboriginal children in the system is currently underway.

This work will inform EIRD's work in identifying priority areas for prevention and early intervention. For the full report [click here](#)
