CHAIRPERSON'S REPORT

It is my great pleasure to present the CF&KC – SA Chairperson's report for 20/21. It has been another challenging, but good, year for our organisation.

In last year's report I noted that

- in 2018/19, our first year as a funded organisation, we were effectively in startup mode, and
- In 2019/20 we faced one of the most challenging years in history with fires and a global pandemic.

With the fires over, and the pandemic becoming increasingly being treated as business as usual, 20/21 has been a year of consolidation, and growth.

Here are some of the highlights.

- Our membership continues to grow. As at 30 June 21 our membership was 987. (it is now over 1000) We are grateful to you all for putting your trust in us.
- We continue to provide individual advocacy for an increasing number of Carers. This work is hard and, at times, unrelenting. Our advocates and the Carers they work with, are often faced with the same issues arising again and again. I am deeply impressed by the fact that they respond not by becoming dispirited, but by becoming increasingly passionate. I am grateful for their commitment.
- We have (with funds secured from a Law Foundation grant to employ a Legal Consultant) built relationships with a number of lawyers and legal services. We now have Memoranda of Understanding with the Aboriginal Rights Movement, the Women's Legal Service of SA and Southern Community Justice Service and a short list of lawyers and barrister who are willing to work for Carers either at a discounted rate or pro bono. This work is part of a long term strategy. Our core funding (which comes from the Department for Child Protection) does not fund us to provide legal advocacy. This limitation means that Carers facing tribunal hearings are sometimes unrepresented (by contrast to the department who are represented by Crown Law). Our response to this evident unfairness has been to reach out to other organisations and individuals on behalf of our members in an effort to find Carers the representation they deserve. This work is ongoing.
- We have continued our behind-the-scenes lobbying including with government, opposition and cross bench Members of Parliament. I think we can safely say most relevant MP's now have a good understanding of the challenges Carers face and of the work of our organisation. This work is also part of a longer strategy with 2022 being an election year for all levels of government in SA, and the year in which the Child and Young Persons (Safety) Act will face its first full review.
- We have continued our association with the Bradford Institute and in 20/21 facilitated 91 Carers to complete a Diploma of Community Services or a Graduate Certificate in Community Services. Again this work has a strategic purpose. Our intention is to provide Carers with qualifications that honour and recognise their incredible existing skills. It is also to equip Carers who often set aside their own needs with a qualification that can lead to paid work in the

sector (either during or after being a Carer). Carers also report that the qualification gives them both the confidence and the language they need to talk to, and be heard by, the department – again helping address the imbalance of power inherent in the Carer/department relationship.

In June 21 we hosted the hugely successful virtual National Foster and Kinship Carer Conference. The decision to 'go virtual' was not taken lightly and a number of us were concerned that a virtual conference could not replicate the 'in-person' experience. As it turned out we were blown away by what the technology made possible. Many delegates were from rural and regional SA and Australia more broadly – who generally consider city conferences beyond their reach. And it allowed us to include some incredible speakers from other parts of the world. But the thing that most impressed me, was the ability of the conference platform to allow for Carer – Carer communication. It was a privilege to see and hear the way Carers shared ideas and tips – and provided (in some cases life-changing) support to fellow Carers across the airwaves. It was an unforgettable experience.

That brings me to my thanks

- To our staff. The work doesn't let up, we continued to navigate the challenges of COVID, and this year we had the conference too. It was an incredible effort. Particular thanks to Fiona Endacott (our CEO) and Nat Baron (our Admin and Events Co-ordinator) for work on the conference. Thanks too to our advocates (Sharee Borlace, Dion Zisos, Tandanya Allain, Alicia Ladiwala and Isabella Furnari) and our Legal Consultant (Jackie Nevin) for tirelessly working for our Carer members.
- To our board: Particular thanks to Hastings Chikuse (our Treasurer) and Jan Stevens (our Deputy Chair) – both of whom left the board this year due to other commitment. And huge thanks to the rest of the board Kelly Mathews, Terry Harris Plane, Dr Sara McLean, Emma Anderson, Sarah Ventress, Cynthia Fielding and (new board member) Phoebe Zander. (Phoebe is an experienced Carer with extensive expertise in providing care for children with a disability. She is currently serving as our Treasurer.) We deeply appreciate the (unpaid and dedicated) time and effort all Board members have given (and continue to give) in the service of Carers.
- To our volunteers: We host a number of students each year social work students on placement and more recently research students all of whom add considerable value to the organisation. Thanks to Alisha Ladiwala, Amanda Quince and Emma Feagan. We are also grateful to have had Sonja Brown as our Youth Consultant on our Board, bringing with them their lived experience in the care system. We have recently welcomed Felicity Graham in this role for the 2021/22 year.
- And finally to our members: I remain inspired by the work you do and consider it an honour to Chair your organisation. Thank you for the opportunity.

CEO REPORT

What an incredible year 2020/21 was for our organisation. As CEO, I am immensely proud to share the incredible successes our staff and volunteers achieved for the South Australian Carer Community, ensuring the Carer voice is heard and their rights upheld.

We spent the past 12 months continuing to establish ourselves as the peak representative body for SA foster and kinship carers, raising awareness of our organisation and sharing the outcomes we achieve for the Carer community.

Our talented Carer Advocacy Team continued to support foster and kinship Carers have their voice heard and be consulted as part of the vital care team for their children and young people. We delivered multiple information sessions to the Carer community on topics such as Carer payments and cyber safety, and published ten brilliant Carer guides brimming with crucial information our members requested. Thank you Sharee, Tandanya, Isabella, Alicia and Dion for your passion, commitment and incredible skill in supporting our Carers so wonderfully.

Despite a few COVID lockdown setbacks, we navigated multiple opportunities to still connect Carers together, through our Family Fun Event at AFL MAX, Fringe Festival tickets, our reference groups, weekly emails packed to the gills with important information and the innovative virtual circus shows generously donated for our membership to enjoy.

Behind the scenes Natalie Baron, our hardworking Administration & Events Coordinator found these incredible opportunities for Carers, and worked double time to ensure tickets were shared and memories made for our Carer families.

We increased our ability to understand legislation and the legal rights afforded to our Carer membership, thanks to the dedicated efforts from Jacquie Nevin, our Legal Consultant. We have supported many carers with their reviewable decisions paperwork, ombudsman applications and complaints processes thanks to Jacquie's know how. This is complex terrain for our non-legal team, but an area we are bravely and confidently traversing for, and with, Carers.

We have fearlessly embarked on making our presence felt on both a state and national level, with regard to legislation amendment and systemic advocacy. We have met with SA politicians in both the lower and upper house to make the case for Carer rights, particularly with regards to the Care Concerns process and the right to review. These steps are incremental but are moving in the right direction. I look forward to seeing how it unfolds over the next year.

On a national level, CF&KC-SA has co-partnered with our interstate peaks, successfully forming a National Foster & Kinship Care Collective consisting of the peak bodies in WA, NT, QLD, Vic, Tasmania and SA. This collective is dedicated to lifting the national presence of foster and kinship carers, and executing much needed systemic change, lobbying for financial security for our community.

And lastly, we delivered the very first fully virtual National Foster & Kinship Care Conference over 2 full days in June 2021. We welcomed over 400 delegates to attend our conference, filled with incredible speakers, beak out rooms and fabulous keynotes presentations. It was a new and innovative delivery of a conference traditionally run in a face to face manner. It was a calculated risk, but one that was worth the effort. Carer feedback was fantastic, engagement in topic content was fast and furious and delegates left feeling connected and informed. An absolute home run for our organisation and the wider Carer community.

I would like to take the opportunity to thank our Board and our Members for guiding our work. Your voice informs the work we do. We are here for the Carer community and we thank you.

OUR ACTIVITIES

ADVOCATE

During the 2020/21 period CF&KC-SA continued to clearly and confidently promote the voice of Carers, ensuring the Carer community is recognised as a crucial part of the child protection system. Our advocacy support, both individual and systemic, continued to provide Carers with the opportunity to participate in decisions that impact the children and young people in their care, and aims to ensure their rights as Carers are promoted and protected.

Our Carer Advocacy Service moved into its third year of operation as a fully funded service, continuing to operate at two levels; individual and systemic. Advocacy continued with a steady uptick of cases, as Carers across SA progressively became aware of the support provided by our advocate team. During 2020/21 our Carer Advocacy Service recorded approximately **338 occasions of individual advocacy, inclusive of our inform and connect service delivery support.**

- 505 texts sent
- 2,410 emails sent
- 98 in person meetings
- 1,338 phone conversations and website responses

A combined total of more than 1,640 hours of support provided by three part time advocates.

The Carer Advocacy Team wishes to acknowledge the strong partnership approach to supporting Carers with the DCP and agency staff across South Australia, who took the time to review the individual circumstances for Carer families and work towards positive outcomes. Our team operates with pride and respect with all stakeholders, ensuring the pillars of the Statement of Commitment for Foster & Kinship Carers is the foundation for all advocacy cases.

We once again thank all our Members and Carers who contacted CF&KC-SA over the past 12 months and trusted us to help. Your faith is our service and fulsome feedback is gratefully appreciated.

"The Carer Advocate heard my voice, they empathised with the situation and they were always on the same page with me. They understood my goals and what I wanted to achieve" - Carer feedback on Advocacy support

"They left no stone unturned, they sent email after email and made themselves available all the time. Prior to that I had no one, they validated how I was feeling and understood what I was trying to get. They made me feel safe and it wasn't just a job to them, they wanted to help. I never felt that I was burden." - Carer feedback on Advocacy support

"The advocate did a phenomenal job in supporting us and I wish I knew your organisation existed earlier" - Carer feedback on Advocacy support Our **systems advocacy** continued to focus on issues raised by Carers via the individual advocacy cases, our 2020 annual survey and pertinent information shared from calls to our 1800 number. Areas of consistent concern requiring systemic change included:

- 1. Care Concerns: i.e. inconsistent process, poor execution by frontline staff with Carers, no mechanisms for reviewing determinations and the excessive length of time taken to review allegations
- 2. End of placement practice and the negative impact on Carers including grief and loss
- 3. Respite entitlements
- 4. Education: lack of consultation with Carers, lack of consistency across schools, deficit in trauma informed frameworks within schools, one plans just words on a page
- 5. The experience of Aboriginal kinship carers and Aboriginal Placement Principle
- 6. Financial agreements and Carer payments
- 7. Carers not receiving communication from DCP in a prompt and transparent manner, particularly after decision making that impacts Carer families
- 8. Unavailability and lack of transparency regarding DCP policy & procedure, references as the basis of decision making

CF&KC-SA addressed the aforementioned areas of systemic change by way of reference groups, information sessions, bespoke support groups, lobbying with DCP directly for information and pursuing involvement in the Care Concerns Reform Project.

In addition to the issues of systemic change raised through our individual advocacy efforts, we released our fourth annual **Foster & Kinship Carer Survey** asking Carers to tell us about the challenges and successes of providing family based care. We received **210 responses from Carer households** across the state. More Foster Carers responded than Kinship Carers with 45% of respondents from a rural and remote location.

Carers stated their greatest worries included:

- Care Concerns
- Removal of their child or young person
- Workers making decisions without Carer consultation; and
- Not having enough support to meet the needs of the child.

Carers also reflected their **greatest challenges** regarding their caring journey was:

- Lack of respite
- Challenging behaviours of their young people
- Inadequate support from the child protection system; and
- Poor communication and feeling disrespected by DCP.

With regard to **training and information** preferences, Carers requested (in order of need):

- 1. Behaviour management training (including managing challenging behaviours)
- 2. Helping their child reach their full potential

- 3. Dealing with (and responding to) the impact of trauma experienced by their young person; and
- 4. Carer self-care.

We are pleased to report we have actively pursued the areas of greatest worry and challenges through a variety of systemic advocacy through tailored reference groups to provide feedback to DCP and a development of the Statement of Commitment for South Australian Foster & Kinship Carers.

Within the Connecting Foster and Kinship Advocacy Team it is considered a privilege to work alongside such resilient, generous and open hearted Carers. The team is very aware of the adversity faced by Foster and Kinship Carers and share a passion in working to ensure that Carers voices heard and their rights upheld.

This year has seen a significant increase in engagement with the Advocacy Service from the Carer Community, demonstrating the necessity of the service and the ongoing issues that carers face in providing care for vulnerable children and young people.

On an individual level, the advocacy team are working alongside carers to have their voices heard and ensure that they are appropriately involved in relevant decision making processes that impact the children and young people in their care. The consistent themes that arise through the individual advocacy helps to guide our Systemic Advocacy. Some of these themes include: Ensuring

that the Child and Young Person Safety Act is followed i.e. Adequate and meaningful carer consultation in decision making process; Process and Practice around Care Concerns, Information Sharing, ensuring that the Foster and Kinship Care Statement of Commitment is upheld by all stakeholders.

Whilst change can be slow and incremental, the Advocacy Team are committed to their work with the Carer Community and continue to push for results for all carers and the children and young people in their care.

In addition to our individual and systemic advocacy activities, we were involved in many other areas of work across the child protection sector attending over **250 sector meetings**, including regular meetings with The Honourable Minister Rachel Sanderson, Minister for Child Protection and Department for Child Protection executive team members including DCP Chief Executive Cathy Taylor and other key stakeholders where we raise common issues and seek improvements to policy, process and legislation.

<u>SUPPORT</u>

Our support services spanned across South Australia, reaching Carers via telephone calls, emails, website enquiries and Facebook contact. The team demonstrated their skill and professionalism supporting Carers both virtually and face to face.

During the 2020-21 year, CF&KC-SA:

- recorded 1,300 phone calls (inclusive of both 1800 & Carer Advocacy calls)
- replied to 82 general email, event and website enquiries
- engaged with a growing Facebook community 1,497 Likes and 1,596
 Followers as at 30 June 2021

Topics for CF&KC-SA support services emerge via phone calls received through our 1800 number, our individual advocacy cases in addition to the Carer voice captured in our annual survey. Two crucial support services that emerged through these pathways focussed specifically on the needs of Kinship Carers and the Grief and Loss Carers experience when placements end. continued to deliver the extremely successful Greif and Transition Group, supporting Carers through end of placement, exploring grief and loss through a restorative practice lens.

The Grief and Transition Support group has been running since November 2019. It is an open group for Foster and Kinship carers, facilitated by CF&KC-SA volunteers and staff, meeting on a monthly basis.

Due to the often temporary nature of Foster and Kinship care, Carers experience of grief and loss is a common experience but is not well recognised and understood within the wider community. This reduces carers abilities to openly grieve and express the depths of their emotions in a space where they feel safe, supported and understood.

The key aim of the group is to provide a safe place for Carers to express their emotions where they feel their grief and loss is understood and validated, whilst integrating strategies and resources to support carers cope with their experiences.

In the past year we have seen a handful of regular attendees say thank you and goodbye to the group as they felt that they were now in a place where they no longer required the ongoing support of the group. This is something that has been celebrated by all involved, as it demonstrates that the service is providing meaningful outcomes for the carer community.

The positive results of the group have also been validated through an Evaluation of the group by Professor Damien Riggs (Flinders University): "There's no disenfranchisement when you're sitting in that room": Evaluating a South Australian grief and loss support group for foster and kinship carers. The article highlights that the group is having the intended outcome, of carers feeling heard and validated with the support of others with similar experiences.

The experiences and stories shared by this support group continues to guide our systemic lobbying regarding the treatment, support and retention of Foster & Kinship Carers.

OUR MEMBERS

Members play an important part in shaping the work of CF&KC-SA and improving the system for Carer families across South Australia. The support of our Members ensures we advocate on the most relevant issues facing our Carers, and we can speak with confidence to the issues that need improvement, and the services that need to be developed.

We are pleased to report an increase in our membership over the past year. As of 30 June 2021, CF&KC-SA recorded **987 active Members**. As a peak body, it is vital we understand the needs of our Foster & Kinship Carer Members so we may best represent their needs in CF&KC-SA's advocacy efforts and service development.

<u>INFORM</u>

CF&KC-SA continued to provide high quality, relevant information to the South Australian Carer community, ensuring it was delivered in a variety of mediums to maximise accessibility.

The information and education projects CF&KC-SA presented during 2020/21 included:

 - 8. Effortless self-care for Carers (via virtual delivery) presented by Michael Place
- Published ten **Carer Guides**:
 - 1. The Youth Court
 - 2. Wills & Estate Planning
 - 3. How to draft a SACAT application
 - 4. Long Term Guardianship Specified Person Application process
 - 5. The Carer Non Approval Process
 - 6. What is a Care Team meeting
 - 7. Understanding the Children and Young People (Safety) Act 2017
 - 8. Reviewable Decisions
 - 9. External Review at SACT
 - 10. What is a Complex Case Review Meeting

Each Carer Guides is developed using input from Carers accessing our Advocacy Service and the CF&KC-SA support line for assistance. All Carer Guides are available on our website for all members of the child protection sector to access.

<u>CONNECT</u>

CF&KC-SA offered several opportunities for Carers to connect through events and activities prior to the pandemic, with a focus on providing information about current issues and offering a range of opportunities to share the achievements and challenges involved in parenting within a family based care setting.

Opportunities to connect over the past year included the following events:

- Family Fun Event at AFL MAX, attended by 89 Carers & 177 children & young people enjoyed the opportunity to connect with other Carers and involve all members of their family. Children and young people (and some adults) enjoyed an assortment of activities available in the nation's first immersive footy skills and entertainment centre. Along with CF&KC-SA staff, the Guardian for Children & Young People team joined us (along with their mascot Oog!) and Amy from Create Foundation provided badge making fun for all
- Two **reference groups** regarding areas of systemic change for our Carers including; Carer payments and accessing and maintaining education for children & young people in family based care
- Our monthly Grief & Transition support group
- Adelaide Fringe Family Fun Event (invitation only special event) 24 Carers & 48 children & young people in care (72 tickets)

CARER EDUCATION

Throughout 2020/21 we continued our collaborative partnership with the Bradford Institute for Advanced Education, supporting our Carer members to participate in further education. At the end of September 2021 (just outside this reporting period) we reached a milestone of **77 Carers graduate with a Diploma of Community Services**, since the pilot began in 2019.

Of these graduates 35% have pursued further study since completing their Diploma in areas such as:

2021 NATIONAL FOSTER & KINSHIP CARE CONFERENCE

On the 11th and 12th of June 2021, we were thrilled to (finally) deliver the National Foster & Kinship Care Conference to the Australian community. The conference was postponed from 2020 due to the pandemic and rescheduled to June 2021 as a fully virtual event, ensuring the Carer community could access quality content irrespective of isolation, lockdowns and locations. The national conference has a rich, long history as a face to face event, hosted by our sister peak bodies on a regular rotation. We were proud to have pivoted seamlessly to pilot the event in a new format, a fully virtual event, using a state of the art conference platform.

We were delighted to welcome over 400 delegates to the conference from across Australia, with the benefit of the platform to allow individuals to access the speakers presentations for a full 12 months after the event, with South Australia's Child Protection Minister, The Honorable Rachel Sanderson, provided our opening address.

The conference theme was Connect, Share & Learn; which we consciously integrated into every element of our event. Our speakers presented across four streams over two days, with the program including six plenary sessions and 20 In Conversation workshop sessions. The conference platform had a foolproof ongoing chat stream for delegates to ask questions and share information in addition to a break out room for Carers to connect with each other, across the country. We were thrilled to intersperse short activities between presentation, providing delegates the opportunity to recharge with sessions including tea making, mindfulness colouring and laughter yoga in addition to a live comedy show on the Friday night from the wonderful Chris Ryan. Delegates enjoyed the snacks during the show, which were included in the conference packs our CF&KC-SA team lovingly packed and posted prior to the event.

Our major speakers included:

- neuroscience educator Nathan Wallis, whose subject was Change Your Brain, Change Your Life ;
- South Australian Primary Principals Association President Angela Falkenberg, on Starting Strong, Staying Strong ;
- Jeremy 'Yongurra' Donovan, Indigenous storyteller from the far northern Qld Kuku-Yalanji tribe, on overcoming adversity and healing ancestral wounds for Aboriginal children and young people;
- Associate Professor Damien Riggs, on Supporting Transgender Young People in Care; and
- Dr Stacy Blythe, nurse, research fellow and lecturer, on Supporting Children and Young People with a History of Pre-natal Substance Exposure.

We were delighted with the range and quality of the speakers we were fortunate to have as part of this important event, all working collaboratively to assist and enhance the role of foster & kinship carers in the child protection sector nationally.



OUR LEGAL ADVOCACY

In December 2020 CF&KC-SA applied for, and successfully secured, a second grant from the Law Foundation of South Australia to progress the projects implemented from our first grant. We were fortunate to appoint Jacquie Nevin as our Legal Consultant in March 2021.

Within her role, Jacquie has confidently led a number of crucial projects to advance the rights for Foster & Kinship Carers, in addition to ensuring our advocacy team are comprehensively aware of the legislative rights afforded to the Carer community.

We have successfully collaborated with four South Australian Community Legal Services, developing Memorandum of Understandings, outlining a partnership approach to supporting Foster & Kinship Carers. The MOUs are with:

- 1. Southern Community Justice Service
- 2. Women's Legal Service South Australia
- 3. Aboriginal Legal Rights Movement
- 4. Northern Community Legal Service

During 2021, CF&KC-SA developed a Scope of Collaboration with The Adelaide University Legal Advice Clinic to support our Carer membership access legal advice and drafting by final year law students, who are supervised by practicing solicitors. The law students provide advice and draft internal review applications for (and with) Carers as these review applications are extremely time consuming for our Carer Advocates to draft.

This new collaboration will ensure our Advocacy team remain focused on supporting Carers whilst utilising the legal resources and skills of the law students through the clinic.

In addition to our MOUs and collaboration with the Adelaide University Legal Advice Clinic, CF&KC-SA now has a modest, standalone pro bono pool of solicitors and barristers for Carers to access as part of their reviewable rights process. This is a work in progress, one we hope to expand upon in 2022. As the CF&KC-SA Legal Consultant I have worked closely alongside the Advocates ensuring Carers are correctly informed of their legal rights and legislated avenues available to them.

Working closely with the Advocates has given me first-hand knowledge of the cases and ensured the pertinent legal issue in a matter is extracted in a timely manner. This may be as simple as reminding the Department of their legislative requirements through an email or drafting complaints to the Department and Ombudsman, or ensuring care concerns are dealt with expeditiously without the matter escalating or proceedings to an internal review.

For matters that have proceeded to internal review my role has been integral in supporting the pro bono lawyers that we have engaged including drafting timeline of events, collating briefs, attending Conciliation/Mediation at SACAT, attending pro bono lawyer/barrister meetings. By providing this level of support at SACAT matters ensures the Carer Advocates are able to continue supporting carers in other matters.

In this role I have had first-hand experience of the systemic issues effecting Carers legal rights. Of particular note is the delay in internal reviews and the impact this has on Carers and the likelihood of a positive outcome.

My findings inform the organisation's systemic advocacy efforts and used as a basis to lobby for lasting legislative change.

I look forward to building upon our work to date and progressing the rights of Foster & Kinship Carers in 2022.

Note 1. General information

Connecting Foster & Kinship Carers - SA Inc. is a not-for-profit incorporated association, incorporated and domiciled in Australia.

A description of the nature of the incorporated association's operations and its principal activities are included in the members' report, which is not part of the financial statements.

The financial statements were authorised for issue on <u>16</u> November 2021.

Note 2. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out either in the respective notes or below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Basis of preparation

In the members' opinion, the incorporated association is not a reporting entity because there are no users dependent on general purpose financial statements.

These are special purpose financial statements that have been prepared for the purposes of complying with the Australian Charities and Not-for-profits Commission Act 2012 and associated regulations. The members have determined that the accounting policies adopted are appropriate to meet the needs of the Board of Management of Connecting Foster & Kinship Carers - SA Inc.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the disclosure requirements of AASB 101 'Presentation of Financial Statements', AASB 107 'Statement of Cash Flows', AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors', AASB 1048 'Interpretation of Standards' and AASB 1054 'Australian Additional Disclosures', as appropriate for not-for profit oriented entities.

Historical cost convention

The financial statements have been prepared under the historical cost convention, except for, where applicable, the revaluation of financial assets and liabilities at fair value through profit or loss, financial assets at fair value through other comprehensive income, investment properties, certain classes of property, plant and equipment and derivative financial instruments.

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the incorporated association's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 3.

Revenue recognition

The incorporated association recognises revenue as follows:

Grant income

Income arising from the contribution of an asset (including cash) is recognised when the following conditions have been satisfied:

- the Association obtains control of the contribution or the right to receive the contribution; (a)
- it is probable that the economic benefits comprising the contribution will flow to the Association; and (b)
- the amount of the contribution can be measured reliably at the fair value of the consideration received. (c)

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Note 2. Significant accounting policies (continued)

Other income

Other income is recognised when it is received or when the right to receive payment is established.

Income tax

As the incorporated association is a charitable institution in terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST receivable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

Note 3. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. There are no critical accounting judgements, estimates and assumptions that are likely to affect the current or future financial years.

Independent auditor's report To the members of Connecting Foster & Kinship Carers – SA Inc.

We have audited the financial report of Connecting Foster & Kinship Carers – SA Inc. (CF&KC-SA), which comprises the statement of financial position as at 30 June 2021, the statement of profit or loss and other comprehensive income, the statement of changes in equity, the statement of cash flows for the year then ended, the notes to the financial statements including a summary of significant accounting policies, and the CF&KC-SA members' declaration.

In our opinion the financial report of CF&KC-SA has been prepared in accordance with Division 60 of the *Australian Charities and Not-for-Profit Commission Act 2012*, including: (a) giving a true and fair view of CF&KC-SA's financial position as at 30 June 2021 and of its financial performance for the year then ended; and

(b) complying with Australian Accounting Standards to the extent described in Note 1 to the financial statements, and Division 60 of the *Australian Charities and Not-for-profit Commission Regulation 2013.*

As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Responsibility of the CF&KC-SA Board of Management (Board) for the Financial Report

The CF&KC-SA Board is responsible for the preparation of the financial report that gives a true and fair view and has determined that the basis of preparation described in Note 2 to the financial statements is appropriate to meet the requirements of the ACNC Act and the needs of the members. - Conclude on the appropriateness of the CF&KC-SA Board's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the registered entity's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the registered entity to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the CF&KC-SA Board regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
